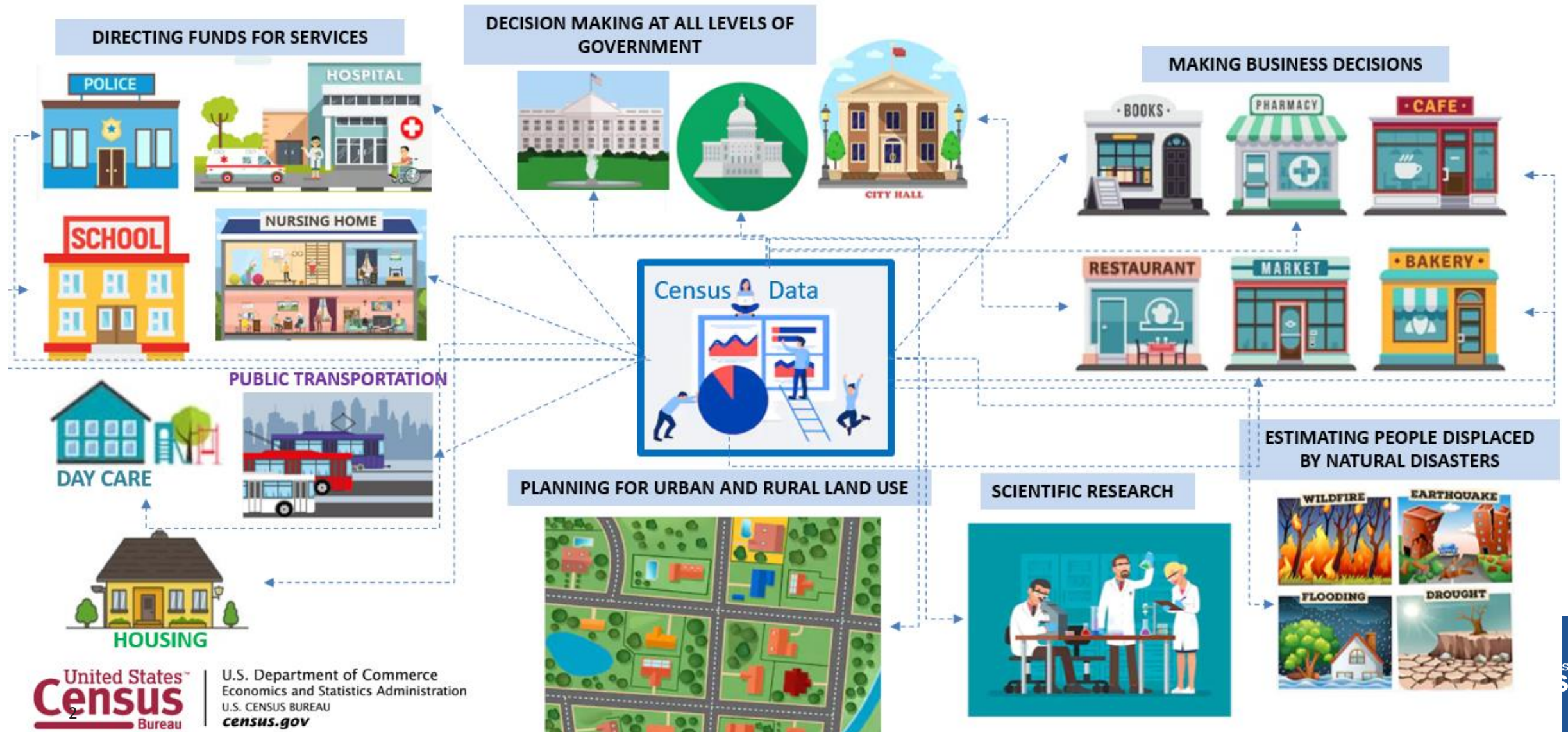

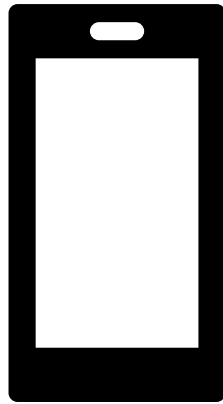

2020 Census Timeline



- **April 1:** This is Census Day, a key reference date for the 2020 Census—not a deadline. We use this day to determine who is counted and where in the 2020 Census. When you respond, you'll tell the Census Bureau where you live as of April 1, 2020, and include everyone who usually lives and sleeps in your home. You can respond before or after that date. We encourage you to respond as soon as you can.
- **Starting mid-April:** The Census Bureau mailed paper questionnaires to homes that had not yet responded online or by phone.
- **April 16 – June 19:** Census takers will work with administrators at colleges, senior centers, prisons, and other facilities that house large groups of people to make sure everyone is counted.
- **May 27 – August 14:** Census takers will interview homes that haven't responded to the 2020 Census to help make sure everyone is counted.
- **December:** The Census Bureau will deliver apportionment counts to the President and Congress as required by law.

Adjusted Operational Hiring



Now that invitations to respond to the Census have been sent to homes across America, over half of the nation has already responded! Thankfully, most have used time during this pandemic to respond to their Census questionnaire knowing that being counted helps to ensure critical funding for their community for the next 10 years.

The Census Bureau is now selecting candidates for positions as Enumerators to ensure those that have not yet responded to their questionnaire are still counted. Enumerators will be conducting Non-Response Follow Up interviews.

Enumerator positions are temporary and flexible during June – September 2020, paying \$25/hour.

2020 Census Jobs

One application qualifies you for any of the following positions:

Position	Pay rate
Office Clerks	\$22.50 per hour
Office Operations Supervisors	\$26.50 per hour
Census Field Supervisors	\$27.50 per hour
Enumerators (Census Takers)	\$25.00 per hour
Recruiting Assistants	\$27.50 per hour

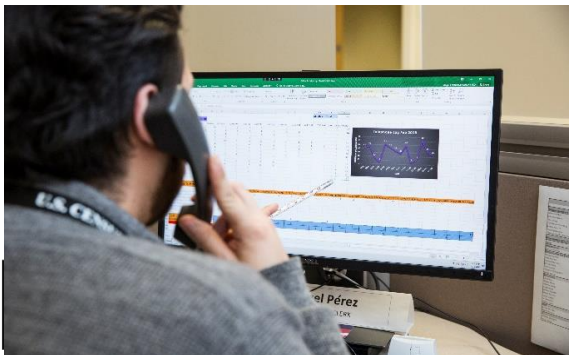
