In this position, Ms. Rayes formed sister city relationships between Los Angeles and San Salvador, El Salvador, Beirut, Lebanon, and Ischia, Italy. Ms. Rayes's professional background and achievements illustrate her commitment to public service and ability to forge cross-cultural relationships, which will be an asset as Ambassador.

Furthermore, Ms. Rayes's professional background illustrates her passion and commitment to global affairs and diplomacy. She was confirmed to the U.S. Institute for Peace Board of Directors in 2021. She also served over six years on the Woodrow Wilson International Center for Scholars as Chair of the Audit Committee. As a Department of State Fellow, she worked at the U.S. Embassy in Cairo under the Economic and Political Section. Nathalie also holds a Masters of Public Policy with a concentration in International Affairs and Education from the University of California, Los Angeles.
